



## Community Use of Schools Rental Rates REVISED - Effective September 1, 2011

The Kawartha Pine Ridge District School Board is committed to offering access to school spaces at affordable rates. The Community Use of Schools program is supported with funding made available through the Ministry of Education's Community Use of Schools Grant. This initiative supports access to school space outside of school hours for not-for-profit youth and community groups. Fees charged only partially offset the cost of making facilities available to groups, and are reviewed annually.

\* Not-for-profit student focused groups that benefit the Board's students and/or do not charge participation fees (specified by Ministry and limited to Girl Guides, Scouts, Before and After School programs etc.) and educational programs with key partners (ex. Health Units, Fire/Police, Kinark/PFRC parenting programs, CTDC). 100% waiver of all fees, including custodial overtime on weekends.

\*\* Not-for-profit community oriented groups, including youth activities which charge a registration/participation fee, and adult programs (e.g. youth soccer, church groups, adult recreation, colleges, etc.)

\*\*\* For-profit commercial organizations including concert promoters, dance recitals, fund raising businesses, sports camps with paid instructors, private parties and other business enterprises.

#### **Group Definitions for Saturday Bookings**

\* Not-for-profit student focused groups that benefit the Board's students and/or do not charge participation fees (specified by Ministry and limited to Girl Guides, Scouts, Before and After School programs etc.) and educational programs with key partners (ex. Health Units, Fire/Police, Kinark/PFRC parenting programs, CTDC). 100% waiver of all fees, including custodial overtime on weekends.

\*\* Not-for-profit youth oriented organizations, including youth activities where participants are primarily <= 18 years old. Groups may charge a registration/participation fee, but must provide subsidies for at-risk/low income participants. (e.g. youth soccer and other youth sports, youth theatre, etc.) 100% waiver of custodial fees.

\*\*\* Not-for-profit adult oriented organizations, including adult sports and recreational groups, church services. Groups may charge a registration/participation fee. (e.g. pick up and organized sports leagues, weekly church services etc.) Increased hourly rates reflect the higher costs of custodial supervision on Saturdays.

\*\*\*\* For-profit commercial organizations including concert promoters, dance recital, fund raising businesses, organized sports camps with paid instructors, private parties and other business enterprises. For-profit commercial organizations will be charged an additional fee for custodian wages on an hourly basis at \$35.00 per hour.

Health Units, Fire/Police, Kinark/PFRC parenting programs, CTDC). 100% waiver of all fees, including custodial overtime on weekends.

\*\* Not-for-profit youth oriented organizations, including youth activities where participants are primarily <= 18 years old. Groups may charge a registration/participation fee, but must provide subsidies for at-risk/low income participants. (e.g. youth soccer and other youth sports, youth theatre, etc.) 100% waiver of custodial fees.

\*\*\* Not-for-profit adult oriented organizations, including adult sports and recreational groups, church services (e.g. pick up and organized adult sports, community theatre, weekly church services, etc.). \*\*\*\* For-profit commercial organizations including concert promoters, dance recitals, fund raising businesses, organized sports camps with paid instructors, private parties and other business enterprises. For-profit commercial organizations will be charged an additional fee for custodian wages on an hourly basis at \$45.00 per hour.
