## Background

- The Northglen neighbourhood school was approved as part of the Ministry of Education's 2021-2022 Capital Priorities Program.
- The Ministry of Education approved a new 769-pupil-place Junior Kindergarten (JK) Grade 8 school along with a four-room child care centre (1 infant, 1 toddler, 2 preschool) at the Northglen neighbourhood school site.
- The new school is intended to provide accommodation pressure relief at Charles Bowman PS, Central PS, Hampton Junior PS, M.J. Hobbs Senior PS and Clarington Central Intermediate School.

## Background

- The projected occupancy date of September 2024 has been delayed due to challenges in the current construction environment for capital projects, including access to labour and materials.
- The targeted completion date has been moved to September 2025.
- The Board is proceeding with the review in 2023-2024 to identify the schools and students that will be impacted by this delay, as the Board may be required to develop temporary, short-term plans for those students and schools.

## Background

- As part of the review, administration is also recommending boundary adjustments between the following schools:
  - Harold Longworth PS and Vincent Massey PS
  - Dr. Ross Tilley PS and Lydia Trull PS
- Limited feedback was received on these proposed boundary adjustments.
- The Board is providing an additional opportunity to provide feedback on these proposed changes at this meeting and through the on-line platform.

#### **Community Engagement**

- A community engagement session took place on October 16, 2023.
- Several options were presented at the community engagement session, which are available to view on the Board's website.
- Community engagement included in-person and digital engagement.
- The Board sought input from a variety of stakeholders including parents/caregivers, school staff, school principals/vice-principals and senior administration on these options.
- Opportunity to connect directly with the Family of Schools Superintendent for Clarington Central Secondary School and Bowmanville High School Family of Schools was also provided.

#### **Community Engagement**

- Based on the feedback received, as well as the uneven distribution of enrolment created by Options 1A and 1B, administration recommends that they be removed from consideration.
- It was noted that many families voiced that they would prefer that the Grade 7-8 students from Central PS remain at Central PS.
- It was also noted some families liked the idea of returning Grade 7-8 Enniskillen PS students to Enniskillen PS, while others preferred that the students continue to attend M.J. Hobbs Senior PS.
- Based on feedback received, administration is recommending a hybrid approach to Options 2A, 2B, and 3.

#### Preferred Options – Central PS

- The majority of feedback received from families indicated a preference for Grade 7-8 students to remain at Central PS.
- A portable classroom has been placed on site for the 2023-2024 school year to accommodate an additional classroom required as enrolment grows at this school.
- There is limited space for additional portable classrooms.
- Central PS is projected to grow beyond the school and sites capacity to sustainably manage the enrolment growth.
- If students were to remain at Central PS in 2025-2026, there remains the possibility that they may need to be relocated in the future.

## Preferred Options – Central PS

- Projections have been completed considering the phase out of out-ofboundary students as they graduate.
- Hybrid options consider both scenarios, Central PS as a JK-Grade 8 school or as a JK-Grade 6 School


## Preferred Options – Enniskillen PS

- One option proposed that the Grade 7 and 8 students from Enniskillen PS, who would normally attend M.J. Hobbs Senior PS for Grades 7 and 8, would remain at Enniskillen PS.
- Feedback was mixed, in that some families preferred that the Grade 7 and 8 students remain at Enniskillen PS – while others liked the notion of their children continuing to attend M.J. Hobbs Senior PS for Grades 7 and 8.
- A portable classroom was placed on site for the 2023-2024 school year.
   The site has the potential to accommodate additional portable classrooms, pending a review of the electrical capacity and available space for parking.


## Preferred Options – Enniskillen PS

- Enrolment projections were completed for Enniskillen PS:
  - Remaining status quo (i.e., Grade 7 and 8 students attend M.J. Hobbs Senior PS
  - Enniskillen PS becoming a JK-Grade 8 school.
- Relocating the Grade 7 and 8 students shifts the accommodation issue from M.J. Hobbs Senior PS to Enniskillen PS, therefore administration recommends that no changes be made to Enniskillen PS at this time.


