

Student Accommodation Review: Elementary Family of Schools/Port Hope High School

Q. What does this review mean? Why is it necessary?

- A. The Board is reviewing the current and projected enrolment within the elementary family of schools that connect to Port Hope High School.

Specifically, the Board is looking to address ongoing enrolment pressures at Ganaraska Trail Public School.

The reason this review is necessary is that the projected number of students at the school will significantly exceed the capacity of the school building to house them.

Q. What options to address this problem is administration considering?

- A. Administration is considering a number of options to address these enrolment pressures. These options, along with related data and information, are captured within the Background Study and Options report which is available at the Student Accommodation Review: Elementary Family of Schools - Port Hope High School web page, accessible from the home page of www.kprschoools.ca.

The options under consideration include:

- Ganaraska Trail PS becomes a dual track JK/SK to Grade 4 school and Dr. M.S. Hawkins Senior PS becomes a dual track Grade 5 to 8 school.
- Ganaraska Trail PS becomes a dual track JK/SK to Grade 3 school and Dr. M.S. Hawkins Senior PS becomes a dual track Grade 4 to 8 school.
- Ganaraska Trail PS becomes a dual track JK/SK to Grade 4 school, Dr. M.S. Hawkins Senior PS becomes a dual track Grade 5 to 8 school and North Hope Central PS becomes a JK to Grade 4 school.
- Boundary Adjustment between Beatrice Strong PS, Ganaraska Trail PS and/or North Hope Central PS.

Q. How can I be a part of the consultation on these possible changes?

A. We are inviting parents from these school communities to join us at the parent meetings scheduled below to learn more about the accommodation challenges we are addressing, and to provide feedback and input on these issues and possible solutions.

- January 16, 2023, 6:30 p.m., Port Hope High School

Q. What if I can't attend these meetings but still want to share my input?

A. All meeting information packages will be available on the dedicated section of the KPR website, and there will be an online option for parents to share their thoughts and comments.

Q. What happens after the consultation process? When will a decision be made on any possible changes to the schools involved?

A. After consultation with parents and community, it is expected that administration will make recommendations to the Board for a final decision scheduled for February, 2023.

Q. What factors will administration consider when identifying future recommendations?

A. Administration will begin by reviewing the feedback and information provided by parents and community through the consultation process.

Two significant factors that will also guide decision making in this area will be:

- how many students attend the schools now, and how many may be expected in future years, and
- the educational program available to students
