TOPIC: **Northglen Neighbourhood School Accommodation Planning Update**

BACKGROUND

1. The Northglen neighbourhood school was approved as part of the Ministry of Education's (MOE) 2021-2022 Capital Priorities Program. A 769-pupil-place Junior Kindergarten (JK)–Grade 8 school was approved along with a four-room childcare centre (1 infant, 1 toddler, 2 preschool) at the Northglen neighbourhood school site.
2. The Northglen Neighbourhood School Accommodation report was presented to the Resource Committee on May 3, 2023. The report provided a detailed framework for the boundary review process on how to establish the boundaries (or school attendance area) for the new school. An updated report went to the Committee on November 29, 2023.
3. A consultation package that included a background study and scenarios for consideration was developed to inform the review. The consultation package was shared with stakeholders and posted on the board website on October 4, 2023.

STATUS

4. A community engagement process took place to seek input from a variety of stakeholders including parents/caregivers, school staff, community members, trustees, school principals/vice-principals, and senior administration. The community engagement process included an in-person engagement, digital engagement, and the opportunity to connect directly with the Superintendent of Student Achievement for the Clarington Central Secondary School and Bowmanville High School Family of Schools. The in-person community consultation meetings were held on October 16, 2023, and December 7, 2023.
5. Options that were presented to the community at the community engagement meeting on October 16, 2023, are noted below. A map illustrating the study areas that were used to formulate the proposed options are outlined in Appendix A.

For reference, Table 1: Study Area Analysis illustrates the number of students currently residing in each study area.

Option 1A:

- Students residing in study area CB-1 will continue to attend Charles Bowman Public School (PS).
- Students residing in study area CB-2, including the students attending Harold Longworth PS holding school, will attend the new Northglen neighbourhood school.
- Students residing in study area HH-1 will continue to attend Hampton Junior PS/M.J. Hobbs Senior PS.
- Students residing in study areas HH-2, HH3 and HH-5 will attend the new Northglen neighbourhood school.
- Students residing in study area HH-4 will attend Waverley PS.
- Clarington Central Intermediate School will be dissolved. Students residing in Study Area CB-1 will attend Charles Bowman PS, and students residing in study area CB-2 will attend the new Northglen neighbourhood school.
- Grade 7 and 8 students at Central PS will be relocated to Charles Bowman PS.

Option 1B:

- Same as Option 1A
- There would be a change in the grade cohort between Hampton Junior PS and M.J. Hobbs Senior PS, with Hampton Junior PS becoming a Junior Kindergarten (JK)-Grade 3 school and M.J. Hobbs Senior PS becoming a Grade 4-8 school.

Option 2A:

- Students residing in study area CB-1 will continue to attend Charles Bowman PS.
- Students residing in study area CB-2, including the students attending Harold Longworth PS holding school, will attend the new Northglen neighbourhood school.

- Students residing in study areas HH-1, HH-2, HH-4 and HH-5 will continue to attend Hampton Junior PS/M.J. Hobbs Senior PS.
- Students residing in study area HH-3 will attend the new Northglen neighbourhood school.
- Clarington Central Intermediate School will be dissolved. Students residing in study area CB-1 will attend Charles Bowman PS, and students residing in study area CB-2 will attend the new Northglen neighbourhood school.
- Grade 7 and 8 students at Central PS will be relocated to Charles Bowman PS.

Option 2B:

- Same as Option 2A
- Intermediate students would remain at Enniskillen PS instead of attending M.J. Hobbs Senior PS for Grades 7 and 8.

Option 3:

- Students residing in study area CB-1 will continue to attend Charles Bowman PS.
- Students residing in study area CB-2, including the students attending Harold Longworth PS holding school, will attend the new Northglen neighbourhood school.
- Students residing in study areas HH-1 and HH-2 will continue to attend Hampton Junior PS/M.J. Hobbs Senior PS.
- Students residing in study areas HH-3 and HH-5 will attend the new Northglen neighbourhood school.
- Students residing in study area HH-4 will attend Waverley PS.
- Clarington Central Intermediate School will be dissolved. Students residing in study area CB-1 will attend Charles Bowman PS, and students residing in study area CB-2 will attend the new Northglen neighbourhood school.
- Grade 7 and 8 students at Central PS will be relocated to Charles Bowman PS.

6. Feedback from the first community engagement meeting was consolidated and shared with administration for review. This feedback was also shared on the board website under Student Accommodation Planning: Northglen and Elementary Family of Schools - Bowmanville High School and Clarington Central Secondary School. A summary of the community feedback is attached as appendices. Appendix B includes the collated feedback from the October 16, 2023, in-person public consultation meeting. Appendix C includes the collated online feedback received through the ThoughtExchange platform.
7. Based on community feedback and further review, Planning Services proposed that two hybrid options be presented to families at the December 7, 2023 community meeting. The options that were presented to the community are noted below. Italicized sections indicate where there are differences between the two options.

For reference, the table below illustrates the number of students currently residing in each of the study areas.

Hybrid Option 1 (refer to school attendance area map in Appendix D)

- Northglen/Charles Bowman PS - boundary revised to include an additional area of Charles Bowman PS (approximately 90 students would attend Northglen instead of Charles Bowman PS).
- Central PS – Central PS Grade 7 and 8 students will attend Charles Bowman PS.
- Hampton Junior PS/M.J. Hobbs Senior PS - in this option the Brookhill neighbourhood with the exception of students south of Brookhill Boulevard will remain at Hampton Junior PS/M.J. Hobbs Senior PS.
- The students south of Brookhill Boulevard would attend Waverley PS.

- Northglen/Charles Bowman PS - boundary revised to include an additional area of Charles Bowman PS (approximately 90 students would attend Northglen instead of Charles Bowman PS).
- Central PS Grade 7 and 8 students would remain at Central PS.
- Hampton Junior PS/M.J. Hobbs Senior PS – students east of Green Road (approximately 40 students) would attend the new Northglen neighbourhood school.
- The students south of Brookhill Boulevard would attend Waverley PS.

8. Feedback from the second community engagement meeting was consolidated and shared with administration for review. This feedback will also be shared on the board website under Student Accommodation Planning: Northglen and Elementary Family of Schools - Bowmanville High School and Clarington Central Secondary School. A summary of the community feedback is attached as appendices. Appendix F includes the collated feedback from the December 7, 2023, in-person public consultation meeting. Appendix G includes the collated online feedback received through the ThoughtExchange platform.
9. Administration appreciates and acknowledges the feedback and input provided by families. In making the decision, the following main themes were considered:
- Central PS families expressed concern regarding the travel distances and splitting of the 7/8 cohort from the community school. Administration agreed with this concern and recognized the importance of Central PS students remaining at the school at this time. However, it is recognized by both administration and the community that as accommodation pressures continue to increase over the next few years, the option to move the 7/8 cohort from Central PS may need to be reconsidered.
 - Concerns regarding the distance and safe travel of students residing in study area CB-1 were expressed. Administration recognizes that walking to the Northglen Neighbourhood School from this area requires students to travel across busy roads that currently lack sidewalks.
 - Parents and community members expressed concern that Hampton Junior PS students would be moved three times should they be relocated to Northglen in grade 7/8. Administration agrees that consistency is best for students when it can be accommodated.
 - There were concerns expressed regarding students from the Brookhill neighbourhood being separated from their peers. As a result, a second community engagement session was held to present new options.

10. After reviewing all the feedback that was received from both in-person community engagement meetings, as well as the online platform, administration is proposing that the original Option 3 with slight modifications be implemented. Refer to Appendix H for a map illustrating the new school attendance area/boundary.
- The boundary line between Charles Bowman PS (CB-1) and the new Northglen neighbourhood school (CB-2) is Concession 3.
 - Students residing in study area CB-1 will continue to attend Charles Bowman PS.
 - Students residing in study area CB-2, including the students attending Harold Longworth PS holding school, will attend the new Northglen neighbourhood school.
 - Clarington Central Intermediate School will be dissolved. Students residing in study area CB-1 will attend Charles Bowman PS, and students residing in study area CB-2 will attend the new Northglen neighbourhood school.
 - A largely rural area (HH-3) which includes an undeveloped area north of the existing Brookhill neighbourhood and the portion of the Brookhill neighbourhood east of Green Road (HH-5) will attend the new Northglen neighbourhood school.
 - Students residing in study areas HH-1 and HH-2 (which includes a portion of the Brookhill neighbourhood west of Green Road) will continue to attend Hampton Junior PS/M.J. Hobbs Senior PS.
 - Future students that are anticipated from the undeveloped portion south of the existing Brookhill neighbourhood (HH-4) would attend Waverley PS. Central PS will remain a JK to Grade 8 school, however, changes may be required in the near future if enrolment at Central PS continues to trend upwards.

11. Administration recognizes the concerns brought forward from the community regarding the separation of the Brookhill neighbourhood. It is acknowledged that the proposed solution does require this neighbourhood be separated. In

reviewing the proposed options, this recommendation was the most viable. It is important to note that there is a site presently identified on a draft approved subdivision plan for this neighbourhood that is being considered for future pupil accommodation needs, however, the site is not currently available for Board use (i.e., lack of municipal services or road frontage).

12. Administration recognizes that some families may be impacted by childcare arrangements through this decision and makes the commitment to review each situation on a case-by-case basis.

BUDGET IMPLICATIONS

13. There are no impacts on the 2023-2024 budget as a result of the boundary (school attendance area) being proposed.

RECOMMENDATION


1. That the school attendance area for the new Northglen Neighbourhood School described as:
 - The boundary line between Charles Bowman PS (CB-1) and the new Northglen neighbourhood school (CB-2) is Concession 3;
 - Students residing in study area CB-1 will continue to attend Charles Bowman PS;
 - Students residing in study area CB-2, including the students attending Harold Longworth PS holding school, will attend the new Northglen neighbourhood school;
 - Clarington Central Intermediate School will be dissolved. Students residing in study area CB-1 will attend Charles Bowman PS, and students residing in study area CB-2 will attend the new Northglen neighbourhood school;
 - A largely rural area (HH-3) which includes an undeveloped area north of the existing Brookhill neighbourhood and the portion of the Brookhill neighbourhood east of Green Road (HH-5) will attend the new Northglen neighbourhood school;
 - Students residing in study areas HH-1 and HH-2 (which includes a portion of the Brookhill neighbourhood west of Green Road) will continue to attend Hampton Junior PS/M.J. Hobbs Senior PS;
 - Future students that are anticipated from the undeveloped portion south of the existing Brookhill neighbourhood (HH-4) would attend Waverley PS. Central PS will remain a JK to Grade 8 school, however, changes may be required in the near future if enrolment at Central PS continues to trend upwards, and

illustrated in Appendix H of the Northglen Neighbourhood School Accommodation Planning Update Report dated February 28, 2024, be approved and be effective September 2025.



Option 1





Option 2





Overview of ThoughtExchange Results

Between October 16 and November 5, 2023 the Board gathered input from families through an online platform called ThoughtExchange. The following question was asked:

Summary of Top Thoughts:

Top thoughts identified the need for early communication of temporary accommodation plans for next year. Participants emphasized the importance of maintaining established relationships and routines for students, to support mental health, and suggested that students should not be moved during their final year. Some people also expressed concerns about the potential for increased busing and the reliability of transportation services when students could walk to closer schools. Each school community had concerns directly related to their own school boundaries.

Specific Actions Identified

- Timely and clear communication about temporary plans.
- Provide as much notice as possible for families.
- Minimize change and disruption as much as possible and leave as many kids as possible where they are to support existing relationships and connections.
- Consider how this will affect childcare.
- Requests to not make changes when the enrolment impact is only 20-30 kids. Keep kids with their existing friends and peers instead.
- Members of Brookhill community identified they wanted to stay at Hampton Junior PS and M.J. Hobbs Senior PS.
- Central PS families and staff identified they wanted the school to remain JK-Grade 8.
- Some support was expressed for Enniskillen PS as JK-Grade 8.
- Some support was expressed for Charles Bowman PS returning to JK-Grade 8.
- Parents requested an option for their children to stay at their current school or move to the new one.

Overall, participants urged consideration of the best interests of each child and minimizing disruptions to their education and social development.

The top thoughts (rated 3.7 and higher) are included as an appendix.

Hampton Jr students are getting broken into three different schools in the proposals A small school broken into three likely means that students will be separated from important peer relationships they have been forming.

I am concerned for my children. They have made friends and finally have consistency in their school routine after three years of Covid. Moving them is not a good option.









Proposed School Boundaries






Appendix E Future Northglen PS Hybrid Option 2 Proposed School Boundaries

Overview of ThoughtExchange Results

Between December 7 and January 12, the Board gathered input from families through an online platform called ThoughtExchange. The following question was asked:

What are your thoughts and questions about the updated boundary options for the new Northglen Neighbourhood school and boundary changes affecting other nearby schools?

Summary of Top Thoughts:

- There is strong opposition to the proposed hybrid option that would have approximately 90 students close to Charles Bowman travel to the new school and cross Concession 3.
- The impact on students' mental health was questioned. There were concerns about the separation of certain streets from the rest of the neighbourhood, which would separate friends, affect child care and potentially cause distress to children.
- There are concerns about the strain on the bussing system, the safety of children having to walk longer distances to school, and the need for more crossing guards.
- Some respondents argue that the numbers don't justify Central PS losing its Grade 7-8 students and suggest adding an extra portable to accommodate the increase.
- Respondents supported the new options for Brookhill, one of the reasons being that many have daycare in Hampton.
- Some respondents are worried about when they will know school start and end times, and siblings at different schools, which could pose challenges for childcare.

Specific Actions Identified

- Timely and clear communication about plans.
- Allow students with siblings to remain in existing schools.
- Keep kids with their existing friends and peers.
- Consider how this will affect childcare.
- Allow families the choice for their children to stay at their current school or move.

Q1 What are your thoughts and questions about the updated boundary options for the new Northglen Neighbourhood school and boundary changes affecting other nearby schools?

Moving central kids to bowman puts a strain on our already failing bussing system. Utilizing more buses to move students isn't going to work. Centrals bus is late every single day and is hard for parents. This is due to having too many route for minimal drivers. Adding more buses won't work



The first option for the boundary being a stright line across concession 3 was much better. The people who bought here and were told Bowman is the home school should continue going. The kids have been walking to that school for years.



Boundaries should be concession 3 and North People closer to Charles bowman will be going to a school further away and crossing busy road



Concession 3 safety concerns Concession 3 is a high traffic, higher speed main road. Having young children and families cross concession 3 to walk to/from school is too dangerous



The kids moving schools is going to be very hard on them. Charles bowman is on the complete other side of the city. Traffic to that school is already a nightmare. Buses are not reliable, this is going to add a considerable amount of time to an already busy day.



Having 2 or more children at different schools makes no sense, leave Central K-8. All after school activities would be affected if parents have to be walking/driving to multiple schools to pick up there children.



Concession 3 is very busy. We are very close to scugog on Hockley and my child would need to cross at the round about. Let these kids stay at Bowman It's not safe to have school children crossing the road here. There's no crossing guard and there are a lot of people that don't stop to anyone cross.



Boundary lines dip at west scugog all the way to Bons from cons 3. Plz revisit the dip and have it continue across cons3 all the way. Affects my children and their friends in our neighborhood



Children entering grade 7 next fall will be forced out of Bowman for grade 7, and then off again (in my case) to the new school for grade 8?! This is just ridiculous. What a run around for children and parents!! Grandfather in the new school boundaries so existing families aren't impacted.



I live across the road (scugog and bons) would be absurd for my children to have to bus or walk to a different school More tax payers dollars if there is a bus. Currently it takes my kids less than 5 mins to walk there



I live just west of Scugog and south of concession 3 which now puts my kids to the new school. This will be a 20min walk each way vs less then 5 min. The safety of my kids. There is no direct route from my home to the school. They would have to walk along Scugog which is a busy st.



Don't uproot kids within the Concession 3 -> Bons (Scugog -> Scugog) area to be placed at Northglen school which will open over capacity Pulling 90 kids from this subdivision is wrong when there are already kids attending Charles Bowman who are outside of boundaries.



Keep everyone south of Concession at Charles Bowman, and have Charles Bowman AND Central PS both k-grade 8. The new boundary options make no sense, kids should attend the school that is physically closest to them. Less busses on the road.



It is nonsensical to force our 7/8's to attend another neighbourhood school and be pressured to infiltrate into already established social networks. Forcing students to attend a different school disrupts their social networks, which can create anxiety and ultimately hinder their academic progress.




Leave Central a jk to grade 8 school This will cause a lot of emotional harm to our kids to throw them in a different school, just add a portable to central for more kids if needed



We live 1000 metres from the school and takes us 10 minutes to walk to school with our child We bought our house to attend the local schools. He walks with friends every day to school in the neighborhood and has built solid relationships with local friends and teachers



Relocating 90 families in the new proposed plan is not appropriate. Only numbers were considered in this plan. Consideration needs to be made for the impact on the community and safety of children cross concession 3 with no stop signs/lights and a roundabout.



More students at the Northglen school isn't going to fix the problem. Schools that are under capacity should be filled. Longworth school is projected to be under capacity. Sending kids from Bons/Con 3 to Northglen doesn't utilize resources in an effectively.



South of Concession 3/Bons should belong to Charles Bowman. This area is not connected to the Northglen neighborhood. Kids should be able to share a community with their peers. Doing so enhances their sense of belonging and encourages better neighbourhood dynamics.



The new hybrid option being proposed for 90 students who live within walking distance of the school is completely unreasonable Very tight community of students who walk to school, rely on child care in the community and cannot safely cross Concession 3



Boundary for Bowman should be concession 3. Students who can physically see the school from their house would not be allowed to attend there. How does that make sense?



Boundary should be Concession 3 - Keeps school friends geographically closer. Keeps friends together who live close together-within walking distance. Crossing concession 3 to see school friends is dangerous.



Children at Bowman who are south of concession 3 should all remain at Bowman. Maintain connections, avoid disruption, and continued sense of community within the already established community of Liberty/Bons.



New Boundary is an issue We are closest to Bowman with a very short walking distance for my children whereas the walk to North Glen will be 20 minutes or so. It's ridiculous



Boundary Issue Boundary should be north of concession 3, let the kids south of concession 3 stay at Bowman



Concession 3 is a major street thusly making it an obvious option for a boundary. Higher risk when having student possibly walk/ride bikes



Horrible idea Why would kids that live minutes from CharlesBowman get bussed to Northglen? On top of thatgr 7 and 8s from Central will get bussed to Charles Bowman



If the Northglen boundary is Bons ave, that means my kids would have to go to Northglen, even though they are geographically closer to Charles Bowman They stay at Charles bowman, we can walk and not rely on an inconsistent bus



Terrible, concession 3 should be the boundary. Currently I can walk 4 minutes to Charles bowman. I have never driven because it's chaos. NorthGlen is a longer walk, have to cross a round about.



I feel an adjustment needs to be made to be at least to concession 3. It takes us six minutes to walk to Charles Bowman but 15 minutes to walk to NG We've stayed in the area so our kids can grow with the friends they've made and thrive in a familiar environment. This could damage their progress.


